During the period from 1 to 30 June 2023, 17 counter-narcotic events were covered in mass media in CARICC Member States and other countries (*Azerbaijan Republic -3, Kazakhstan - 6, Kyrgyz Republic - 6, Russia - 5, Republic of Tajikistan - 2, Turkmenistan - 1, Republic of Uzbekistan - 2. Other countries: USA - 1*).

Published articles include information on revoking licenses of drug-using bus drivers, on the amount of drugs seized, and on cooperation in the field of counter-narcotics (*Azerbaijan Republic*), growing number of drug addicts using synthetic drugs, challenges in combating the spread of drugs in the city of Almaty, discussing decriminalization of drug use, dangers of vape devices, and the Youth Against Drugs Forum, on the call of the President of the Republic of Kazakhstan to resolutely counter production of synthetic drugs (*Republic of Kazakhstan*), workshops, meetings, campaigns and preventive measures in the field of counternarcotics organized on the occasion of the International Day Against Drug Abuse and Illicit Trafficking (*Kyrgyz Republic, Russian Federation, Republic of Tajikistan, Turkmenistan, Republic of Uzbekistan*), as well as the fentanyl-opioid crisis (*United States of America*).

### BUS DRIVERS WHO USE DRUGS WILL HAVE THEIR LICENSES REVOKED IN AZERBAIJAN



For driving a public vehicle under the influence of drugs, drivers will be stripped of the right to operate vehicles for up to two years.

This is reflected in a proposed amendment to the Code of Administrative Offenses.

According to the draft, driving a public vehicle during passenger transportation by a person entitled to drive a public vehicle under the influence of narcotic intoxication will be punishable by administrative arrest for a period of one to two months with limitation of the right to drive a vehicle for up to two years.

### 243 KG OF DRUGS SEIZED IN AZERBAIJAN



General Department for Combating Drugs seized 243 kg of drugs, total value is estimated at 13 million manats.

It was mentioned that officers of the General Department for Combating Drugs of the Ministry of Internal Affairs carried out actions against members of an organized group smuggling drugs from Iran to Azerbaijan, as well as against persons selling drugs in Baku, Sumgayit, Lankaran, Absheron, Beylagan and other districts. 31 persons were detained during the operations carried out in the last 10 days.

A total of 243 kg of narcotic drugs - heroin, opium, hashish, marijuana, psychotropic substance methamphetamine, as well as 5,300 methadone tablets - were seized. Total value of seized drugs is estimated at 13 million manat.

**DOCTORS DREW A PORTRAIT OF A KAZAKHSTANI DRUG ADDICT**



The number of drug addicts using synthetic drugs is growing in Kazakhstan. This was reported by Kuanysh Altynbekov, General Director of the Republican Scientific and Practical Center for Mental Health.

«If at the end of 2022 there were 18,085 patients on dispensary observation, this is only drug users, today there are 18,328 patients. That is, there is some growth. But most importantly, I would like to point out that there is an increase in the use of new psychoactive substances (synthetic drugs). If in 2018 there were only 147 patients using synthetic drugs on

dynamic monitoring, today there are 731. I would like to emphasize that official statistics include those patients who are dynamically registered, who are monitored and assisted by psychiatrists-drug addicts,» Altynbekov said.

It also became known which regions of Kazakhstan have the most registered drug addicts.

«In Pavlodar and East Kazakhstan regions the rate of drug addicts per 100 thousand population is higher. But this does not say that these regions have the most drug addicts. These figures show that in these regions there is a good detection rate. And there are several reasons for this, perhaps there is more trust in doctors,» said Gulmira Sadvakasova, head of the Center for Information and Analytical Monitoring and a narcology doctor.

Narcologists have also formed a social portrait of a typical Kazakhstani drug addict.

«If we talk about the portrait of a drug addict, it is usually a man (80 percent are male) in the age category over 35 years old. Thus, it is a contingent of middle-aged, male, and in most cases not working, with specialized secondary education. Some of them have criminal records, criminal convictions,» said Gulmira Sadvakasova.

In addition, narcologists say that about 1-1.5 percent of Kazakhstan's teenagers are at risk. This is evidenced by a recent survey among young people. In the course of questioning, they indicated that they had used drugs in

the last 30 days.

We should remind that Kazakhstan intends to introduce a special drug screening for young people. It will take place in the form of questionnaires.

Specialists indicate that new synthetic drugs are very aggressive and get addictive more rapidly.

«Legal and synthetic drugs are actually no different in their action and effects on the central nervous system than those drugs called ‘traditional hard drugs’. They are very similar to traditional drugs that we have known for a long time in terms of their clinical consequences, their effect on the brain, manifestation of intoxication and mental disorders. At the same time, new types of drugs are very aggressive, because replacement of the formula in the molecules leads to the fact that their level of narcogenicity (the speed of forming dependence when using psychoactive substances) is higher,» Sadvakasova explained.

Narcologists explained what signs parents can use to identify the beginning of drug addiction in a child.

«First of all, weight loss. Because the use of synthetic drugs reduces the need for food and sleep. Second, the use of psychoactive substances, including synthetic drugs, definitely affects the mental sphere. Child may have increased anxiety, sleep disturbance, there is a possibility that there will be some hallucinations. He starts to listen, it seems to him that someone is following him, people in the street seem to want to harm him. In other words, hallucinations can be frightening. Quite often we are first to see just such psychotic disorders. That is, a child comes in with psychosis, and then in the process of natural examination it turns out that the psychosis was caused by the use of synthetic drugs. Psychosis passes quickly enough, but addiction remains. Heavy, persistent, with a very pronounced craving for use,» Sadvakasova added.

In case of such symptoms, doctors advise to immediately contact Mental Health Centers, which are available in all regions of Kazakhstan, as well as at polyclinics.

#### «UNFORTUNATELY, A LUCRATIVE BUSINESS FOR YOUNG PEOPLE» - AKIM DOSAYEV ON COMBATING DRUGS



Almaty Akim Yerbolat Dosayev spoke about challenges in countering drug trafficking.

During a meeting of akim with population of Turksib district, a resident said that there are many places in the district where links to drug advertisements are openly posted. She asked to install video surveillance to punish those responsible.

«The spread of drugs and drug addiction, especially among young people, is one of pressing issues on the agenda. Today, unfortunately, it has become a lucrative business for young people - delivery of

black bags by advertising. We are constantly catching them, imposing administrative fines. This is a common problem for the city, and Turksib district is not an exception,» said the akim.

According to Dosayev, together with district akims and the city police department, a lot of work is being done to combat distribution, plus a «Drug Stop» program has been rolled out with the involvement of various organizations and volunteers who help with this. In addition, non-governmental organizations are helping to paint over all these advertisements.

Akim gave assignment to install 585 additional cameras. He asked residents to communicate addresses where drug distributors work.

**zakon.kz** MAZHILIS IS DISCUSSING DECRIMINALIZATION OF DRUG USE

Mazhilis to discuss possibility of abolishing criminal punishment for drug use.

Mazhilismen believe that those who do not sell banned drugs should only be held administratively liable, Astana TV reports.

Deputies are convinced that this will increase effectiveness of efforts to combat drug trafficking.

«It is proposed to transfer part 1 of Article 296 of the Criminal Code «Illegal handling of narcotic drugs, psychotropic substances, their analogs without the purpose of sale» to administrative jurisdiction. At the same time, the exclusion of the attribute «in public places» for non-medical consumption of narcotic drugs will ensure unconditional prohibition of non-medical consumption of drugs».

Snezhanna Imasheva, deputy of the Mazhilis of the Parliament of the Republic of Kazakhstan, member of the AMANAT faction

The MIA assured that the initiative is not an attempt to simplify police work. First of all, the measure will make it possible to determine real level of drug addiction in the population, according to the ministry.

«First of all, we are talking about non-medical consumption of drugs in public places. Today, the number of such offenses has been halved. At the same time, the number of drug users has not decreased, but they have all gone into shadows, preferring to use drugs at home and in other places that are not public».

**zakon.kz** TOKAYEV ON VAPES: ONE STEP AWAY FROM DRUGS

President's speech at the second National Kurultay in Turkestan was about the harm of vape devices.

According to the President, vapes have become something of a fashion among teenagers

«Another scourge threatening the health of the nation has become so-called vapes and various types of electronic cigarettes. Unfortunately, their use has become something of a fashion among teenagers. This is facilitated by wide availability and aggressive advertising about their alleged harmlessness».

They are one step away from drugs, President Tokayev said.

«In fact, young people are putting themselves in serious danger, because vapes are harmful in and of themselves, and they are one step away from real drugs. We need to take systematic and urgent measures to combat this dangerous phenomenon, just prohibitions will not help».

He believes police should take vape devices under special scrutiny.

«Police need to improve efficiency of their work in this direction. I will keep this issue under special control. In Kazakhstan, since 2016, there has been no special document regulating counter-narcotics efforts. Therefore, in last year's message I ordered to put together a comprehensive plan».

He also said that the Government will soon pass a legislation.

«In the coming days, the Government will adopt this important document, which will be a framework for systematic work. The issue of formation of legal consciousness, which was raised by an experienced lawyer Serik Akylbay, is also relevant. It is very important to raise legal literacy of young people. Then everyone will be able to protect their rights and will not violate the rights of others. The foundation of our state will be unshakable if law and order reign in our country».

According to President Kassym-Jomart Tokayev, there are useless specialists. But real professionals will always be in demand.

**zakon.kz** PRESIDENT CALLED FOR A DECISIVE ACTION AGAINST PRODUCTION OF SYNTHETIC DRUGS IN KAZAKHSTAN

At a meeting of the MIA board on 30 June, President Kassym-Jomart Tokayev called for decisive measures to combat production of synthetic drugs in the country.

The President addressed law enforcement officials and noted that drug production has moved into Kazakhstan's territory.

«This is a serious phenomenon that threatens the security of our state. Here it is necessary to unite efforts of all competent authorities to tackle it, otherwise we will fail,» warned

President Kassym-Jomart Tokayev.

Head of state ordered to take the most decisive measures to eradicate all centers of production of synthetic drugs in Kazakhstan. This is a very important task, he emphasized.

A forum «Life and Drugs are Incompatible» was organized in Nauryzbay district of Almaty. In the course of the event, district authorities and police officers heard proposals from those whom the country is trying to protect from addiction - adolescents.

The forum, timed to coincide with the International Day Against Drug Abuse and Illicit Trafficking, was held on 26 June at the Center for Innovative Creativity.

The format of the event was playful, but the usual concept was turned upside down. This

time it was not adults teaching children, but children sharing their vision of the problem and even suggesting solutions. Sometimes unexpected. For example, one of the young speakers asked the question: «Wouldn't it be more effective not to ban nasvay, but to legalize it, so that people could see the consequences of its use?»

There were also statements about alcohol, so-called «one-time use», cigarettes. All through the prism of Almaty schoolchildren's vision.

Adult listeners promised to use some of the initiatives in work.

«There are 102 children in our district who are activists in general. If they see suspicious QR codes, advertisements, drawings, they immediately inform us. Now we have recorded 14 ideas of our children, who have proposed measures to fight drug addiction. For example, they suggested to conduct awareness-raising work with children and parents already from the 7th grade. To make videos about drug addicts and show people what addiction is fraught with. They propose to provide children with leisure time so that they do not have time for dangerous hobbies,» said Miras Nysanaliev, Deputy Akim of Nauryzbay district.

According to him, situation in the district is relatively calm. There are 32 people registered for drug addiction. All of them are over 18 years old. 193 residents suffer from alcoholism. Inspectors of the juvenile police department have brought four entrepreneurs to administrative responsibility for selling tobacco products to persons under 21 since the beginning of the year.

According to the Almaty PD, a total of 381 cases of offenses related to drug trafficking were detected in the city.

«More than 148 kg of substances were seized. Seven drug laboratories were dismantled. 45 dead drop operators were detained. 253 Internet resources engaged in distribution and advertising of drugs have been blocked. Preventive measures are also taken to paint over advertisements on walls,» said Dauren Kobeey, senior operative of the Department for Combating Drug Crime of the Almaty Department of Internal Affairs.

Tomiris Zair, Miss Almaty 2022, also visited the forum. By her own admission, she was amazed at the level of awareness of the new generation.

«I couldn't help but attend this event. I am a resident of this city. I am very concerned about this topic and I am glad that it is being discussed at the proper level. I liked that schoolchildren shared their vision of how to solve the problem».

At the conclusion of the meeting, participants mentioned that the past forum was only one of the points of the comprehensive plan to combat drug addiction.

**MORE THAN 2 TONS OF DRUGS HAVE BEEN SEIZED IN KYRGYZSTAN SINCE THE BEGINNING OF THE YEAR**



The Service for Combating Illicit Drug Trafficking of the Ministry of Internal Affairs of the Kyrgyz Republic summarized results of actions for the first 5 months of 2023.

Prior to the meeting, staff of the Service saw off a number of heads of the Service’s divisions for a well-deserved retirement.

The event was opened by Police Colonel Ulanbek Sultanov, Head of the Service, who in his speech thanked Aidar Shigaev and Ryspek Oskonbaev for their labor, long years of service and their contribution to the fight against drug trafficking.

In farewell, they wished the leadership of the SBNON of the Ministry of Internal Affairs of the Kyrgyz Republic and the entire staff of the Service further success in their work.

Next, a reporting meeting for the 5 months of 2023 was held in a hybrid format.

In the first 5 months of 2023, the internal affairs agencies uncovered 604 drug crimes and seized more than 2 tons of narcotic drugs, psychotropic substances and precursors. Over 160 drug prevention measures were carried out during the reporting period.

During the meeting, the leadership of the Service set a number of tasks to stop drug smuggling of synthetic origin, as well as to strengthen detection and dismantling of drug laboratories, as well as components for manufacture of narcotic drugs.

Several heads of regional departments and a number of employees of the Service were disciplined for poor organization of work.

Police officers discussed with students what methods criminals can use to involve young people in illicit activities and how to stop such attempts. Police officers also warned young men and women against participating in illegal activities and «easy money» that may be offered on the Internet.

Police officers explained to young people measures of administrative and criminal liability for consumption, possession, distribution and sale of narcotic drugs and psychotropic substances.

Students took an active part in discussion of this problem and asked questions, to which they received qualified answers from organizers of the meeting.

At the end of the meeting, speakers wished students to pass transfer exams successfully, and also recommended to lead a healthy lifestyle during the summer vacation, to devote time to sports and to comply with laws of the Russian Federation.

## TODAY IS THE INTERNATIONAL DAY AGAINST DRUG ABUSE AND ILLICIT DRUG TRAFFICKING

The International Day against Drug Abuse and Illicit Trafficking was established in 1987 by decision of the UN General Assembly. It is celebrated worldwide on 26 June.

Illicit production, distribution and non-medical use of drugs is an acute problem of the modern world, the urgency of which is not diminishing. It affects numerous aspects of the life of the global community, jeopardizing its future and shaping a wide range of negative phenomena.

Combating challenges of the criminal drug business, reducing illicit trafficking and availability of drugs for illicit consumption are priority tasks of the state counternarcotics policy. This year, law enforcement agencies of the Russian Federation have carried out extensive work in this area.

In the first 5 months of 2023, 50,100 drug offenses were solved. 33.7 thousand citizens of the country, foreign countries and stateless persons involved in illegal trafficking of controlled substances in the territory of the Russian Federation were detained. 2,156 persons who committed crimes while under the influence of drugs were detected.

At the same time, it should be noted that the stability of drug situation in the country is largely achieved not only through law enforcement measures, but also through implementation of a range of preventive measures. Employees of the Ministry of Internal Affairs of Russia, in cooperation with prevention agencies and with the potential of youth volunteer organizations, are implementing the interdepartmental comprehensive preventive operation «Children of Russia» and the nationwide campaigns «Report Where Death is Dealt» and «Conscript».

Every year in June, counternarcotics events are held throughout Russia with participation of representatives of executive authorities, public associations, counternarcotics youth and volunteer organizations. Conferences and round tables, creative competitions, as well as various cultural and sporting events are held at venues and stadiums, in parks and clubs, in educational institutions and children's camps. These events are among the drug prevention activities organized by GUNK of the Ministry of Internal Affairs of Russia throughout the calendar

year. Their main audience is young people, on whom the healthy and prosperous future of our country depends. In 2022 alone, about 392,500 preventive measures were carried out, covering more than 2 million people.

Statistics show positive results of work in this direction. According to the Russian Ministry of Health, in 2022 the total number of underage drug users decreased by 5.1%. At the same time, the number of adolescents diagnosed for the first time in their lives decreased by 10.5%.

The International Day against Drug Abuse and Illicit Trafficking is another opportunity to remind that every citizen of the country can contribute to the common cause. There are counter-narcotics volunteer movements in Russia's regions, which anyone can join, and police officers are open to help citizens not only during preventive activities.

**газета.UZ** MORE THAN 2 TONS OF DRUGS BURNT IN TASHKENT

More than 2 tons of drugs were burned in Tashkent on International Day Against Drug Abuse and Illicit Trafficking. Law enforcers seized 952 kg of drugs during the whole 2022 and the period since the beginning of this year.

In connection with the International Day Against Drug Abuse and Illicit Trafficking, celebrated on 26 June, an annual action was organized in Tashkent's Yangikhayot district to destroy drugs seized by law enforcement agencies, the press service of the Customs Committee reported.

In 2022 and since the beginning of this year, a total of 952 kg of narcotic drugs have been seized (in 706 cases), as well as 440,000 potent drugs and more than 7,000 psychotropic substances, including 245 kg of heroin, 300 kg of hashish, 143 kg of opium, 228 kg of synthetic drugs, 31 kg of marijuana, 67,000 tramadol tablets, among the drugs seized as evidence.

To date, border customs checkpoints have been equipped with 23 inspection systems, 15 human scanners, 202 X-ray machines and other necessary means to detect smuggling of psychotropic substances.

The National Canine Center of the Customs Committee trains cynologists and service dogs to combat illicit smuggling of narcotics, potent and psychotropic substances.

More than 2 tons 51 kg of drugs were destroyed by burning at the 26 June event.

**NOVA24 UZ** SYNTHETIC DRUGS INCREASING IN POPULARITY IN UZBEKISTAN

Hashish, opium, and heroin remain the most widely available.

1,279 drug crimes were solved in Uzbekistan in 2022.

A total of 917 kg of narcotic drugs, including heroin, opium and hashish, were seized.

In addition, 373,000 potent and psychotropic drugs were stopped from being illicitly trafficked.

The State Security Service noted an increase in seizures of synthetic drugs. Over 32 kg of mephedrone, amphetamine, Alpha-PVP and MDMA were prevented from trafficking in 2022.

Under international cooperation with the FSB of Russia, the GKNB of Kyrgyzstan and Tajikistan, nine active measures and special operations were conducted, as a result of which 11 drug lords were detained and 166.4 kg of drugs were seized.

Earlier it was reported that a shipment of juice with methamphetamine was going to be smuggled into Tashkent. Customs officers suspected the presence of drugs and revealed the scheme.

It should be reminded that schoolchildren will be taught a negative attitude to drugs. New methods will be introduced into educational process to work with children's psyche.

USA TAKES ACTION TO TACKLE FENTANYL-OPIOID CRISIS



Opioids remain the deadliest group of drugs worldwide, accounting for two-thirds of deaths directly related to drug use, according to a 2022 report by the United Nations Office on Drugs and Crime.

The UN estimates that the number of people using opioids in 2020 was double the number in 2010.

USA was the first to be hit by the fentanyl crisis  
Fentanyl overdose deaths reach record high in the United States and Canada

But it's not just a problem in North America. «We

know this problem is going to spread to other parts of the world,» Secretary of State Anthony Blinken said after a meeting with Western Hemisphere mayors to discuss ways to address the synthetic opioid crisis, held on April 28 at the Summit of America's Cities in Denver.

«Criminal groups that manufacture and distribute synthetic opioids like fentanyl are attempting to create markets in other countries and regions,» the secretary of state said.

There is another reason why fentanyl can be considered an international problem: chemicals used to produce fentanyl sold in one country are often produced in some other country. Coordinated action by different countries is needed to address such a threat.

That's why the U.S. government is working closely with authorities in other countries, as well as public health experts, physicians, businesses, and law enforcement officials to address this issue.

For example, during the Summit of the Americas, the United States Department of State and the Denver Office of Forensic Science signed an agreement to enhance forensic capabilities in the Americas for timely detection of synthetic drugs and other trends in drug production and use. Collaboration is designed to enhance action against fentanyl use throughout the United States and abroad.

Coordinated global efforts

The United States leads a coordinated global effort, working with international partners to disrupt the illicit trade in synthetic drugs. These efforts are designed to accomplish the following objectives:

- Preventing illicit drug production;
- Detecting threats arising from drug production and use;
- Countering illicit trafficking in narcotic drugs;
- Combating financing of illicit activities;
- Preventing negative impacts on public safety and public health.

These efforts are yielding results.

In May, the Government of the United States organized a three-week event involving judicial, law enforcement and security officials from 56 countries to exchange experiences to develop ideas for combating the trade in illicit synthetic drugs. Participants included representatives from Botswana, Ecuador, Morocco, Norway and Thailand.

Also in May, the U.S. Department of Justice announced results of a coordinated international counternarcotics operation that was conducted simultaneously in the United States, Europe and South America. During the

operation, 288 arrests were made and a record amount of fentanyl sold on the darknet was seized.

The U.S. government has also imposed sanctions and/or filed charges in connection with fentanyl trafficking activities, including against the Mexican drug cartel Sinaloa. The Department of Justice calls the cartel «the largest, most violent and effective criminal organization involved in fentanyl trafficking worldwide».

«Cooperation between countries around the world ... is critical,» Blinken said after his meeting with mayors.
